## 67. County Councillor's Report

# 68. District Councillor's Report

The elections have taken place which have changed the political composition of the District Council. Individual roles within the council are now being allocated.

Neighborhood Plans have been identified as protective of villages. It is felt that the process will be less onerous than it initially was.

The business case for a unitary council is being considered.

The New Home Bonus should be investigated and application dates noted. It was confirmed that to be eligible a village should be 'affected' by development, not necessarily being where the development it.

It was asked whether there were any limitations to the use of the New Homes Bonus. It was confirmed that there are criteria but is more flexible than s106, it must however be related to the impact of the housing.

## Open Forum

A welcome was extended to the new Parish Councillors. Should the Parish Councillors wish to provide a short introduction they could do so in the Tingewick News. Information to be provided to the editor.

In respect of the new development at the east of the village a resident raised three concerns. Firstly, it was suggested that the access is not what highways recommended. Secondly, drainage, sewage, and flooding is not addressed. Thirdly, it is noted that there are a great deal of five bedroom houses which will lead to an increase in traffic. As the closing date for responses to this application is not until 11th June it was agreed that the Parish Council will consider the application at their next meeting in June when there will be time for full discussion.

## **Planning**

Three village planning applications have been approved 14/03575/APP - 1 Maytree Cottages; 15/00821/APP - 26 The Maltings and 15/00245/APP - Hill Farm.

A planning application has been submitted for 50 dwellings in Finmere. Finmere Parish Council has been consulted.

#### 72. Planter

A request has been received from the Village Cafe to place and maintain a planter in the village. The Parish Council has no objections.

#### 73. Neighborhood Plan

Consideration was given to whether Tingewick should commission a Neighborhood Plan. It was noted that Neighborhood Plans are now a more viable option for smaller villages due to improved processes, reduction in cost and funding. AVDC is also progressing their draft plan and any plan developed by the village may run parallel to this.

It was stressed that the preparation of a Neighborhood Plan will required the lengthy commitment and dedication of a team of residents to more the project forward. If there is not sufficient support in the village it will not be possible to proceed. It was agreed that an advertisement will be placed in the Tingewick Village News seeking committed and dedicated residents who would give the required commitment to the project.

## 74. Correspondence

Heritage-Request for additional inscription on a memorial tablet. Approved Finmere Parish Council - Mere Lane - Request regarding boundaries in Mere Lane, Finmere.

It was agreed that the Parish Council will assist as requested. A letter will be sent to Tingewick Parish residents in Mere Lane enquiring whether they have any information regarding the ownership of the lane.

Western Power- Request to prune trees by the recreation field where they are obscuring electrical cables. Approved.

MVAS- The Clerk presented the statistic for April and May to date. It was agreed that a summary of the statistics will be added to the website twice a year, the first summary to be added in October 2015.

Resident- The use of S106 Money. It was confirmed that the use of s106 money is agreed in consultation between AVDC and the developer. In the case of the development at the east of the village it did not include any money for road traffic calming proposals. There are cases where s106 monies can be used for traffic calming where a development will have a significant adverse impact on the existing road system. However in this specific case the discussions between the developer and BCC suggested that there was no case for traffic calming beyond the development and as such it has not been included in the s106 agreement.

Resident-Concern regarding the entrance to the new development at the east of the village. The Parish Council noted that the proposed entrance was agreed by the respective parties at the outline planning stage, it has already been adjudicated upon and thus the Parish Council has no power to make further representations. Nor, in any event, would it be possible for entry to be gained from Gawcott Road as the land adjoining the road is not owned by the developer.

#### **75. Fete**

Preparations are proceeding well. The beer and cider has received good sponsorship. There will be varied activities and bands will play during the afternoon and in the evening.
